- 2. Use the elements of two-dimensional design to create a variety of compositions that illustrate design principles.
- 3. Demonstrate the proficient use of basic design tools and materials.
- 4. Apply a problem-solving approach to design projects.
- 5. Conduct Internet research on specific designers.
