Course Description:

This studio course is designed for the student with an interest in fine arts. The course will allow students to explore the possibilities of self-expression with media and materials of their own choosing.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Research, select, and describe a project of their choice.
- 2. Research form and design using the Internet and library sources.
- 3. Compile and generate necessary technical information and materials to accomplish the project.
- 4. Apply and practice researched material, assess project progress, and make progress through regular individual critiques.
- 5. Prepare and present a final portfolio which will include notes, research materials, and completed projects.

Course Content:

- A. Selecting an artistic area of emphasis
- B. Researching the project through directed readings, visual research, and Internet resources
 - C. Setting project goals, and gathering necessary materials and supplies
 - D. Individualized demonstrations and critiques Learning Assessments:

Course competencies will be assessed by documentation of research and progress of the project, individual critique sessions, and evaluation of the final portfolio.

Instructional Materials:

Relevant books and periodicals, determined by the instructor and individual student, based on the selected project.
