Course Description:

This course teaches the theory of both open and closed center hydraulic systems. It covers pump overhaul and testing procedures. It also covers the use of hydraulic flow meter and testing procedures.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Draw a block diagram of a simple hydraulic system.
- 2. Disassemble, clean and reassemble a hydraulic jack.
- 3. Clean and inspect a vented reservoir.
- 4. Replace a reusable hose end.
- 5. Install an O-ring.
- 6. Install a seal.
- 7. Install a packing.
- 8. Disassemble, inspect, and reassemble a gear pump.
- 9. Disassemble, inspect, and reassemble a pressure compensated variable displacement pump.
- 10. Disassemble, inspect, and reassemble a pressure control valve.
- 11. Disassemble, inspect, and reassemble a flow control valve.
- 12. Disassemble, inspect, and reassemble a directional control valve.
- 13. Disassemble, inspect, and reassemble a hydraulic cylinder.
- 14. Test a cylinder for internal and external leakage.
- 15. Disassemble, inspect, and reassemble a gear motor.
- 16. Inspect, clean, and test an air-cooled cooler.
- 17. Inspect, clean, and test a heater.
- 18. Draw an open-center hydraulic circuit.
- 19. Show the oil flow in a circuit.
- 20. Perform general maintenance procedures on a hydraulic system.
