## **Course Description:**

This course provides a survey of the significant writers, works, and developments in American literature from roughly 1865 to the present.

## **Course Competencies:**

Upon completion of the course, the student should be able to:

- 1. Demonstrate a complex understanding of the genres, themes, central figures, and key works of the expanding body of American literature.
- 2. Explain the influence of cultural and historical trends upon American literature
- 3. Articulate the distinctive periods and movements of American literature.
- 4. Evaluate and critically examine narratives of American literary history with attention to the role of diversity in its broadest forms.
- 5. Practice foundational research strategies appropriate to the discipline and write focused, convincing analytical essays in clear, grammatical prose.

- B. New American Voices in the 19th Century
- C. The World Wars, Jazz, and Modern Voices
- D. The Literature of Diversity
- E. Creative Nonfiction

### Learning Assessments:

Course competencies will be assessed by written commentaries on assigned reading, reflection or research papers, regular exams, a final exam, and level of active participation in class or group discussions.
