# **Course Description:**

This course explores significant topics, themes, and genres over a range of historical periods through the various lenses of literary criticism. Particular emphasis will be placed on literature created by and/or about traditionally marginalized populations who have encountered discrimination and exclusion in social, cultural, political, and economic spheres.

# **Course Competencies:**

Upon completion of the course, the student should be able to:

- 1. Demonstrate an understanding of the range and complexity of human experience as expressed through the specified literature.
- 2. Identify and articulate common themes and distinctive features in the specified literature.
- 3. Explain the impact and implications of the specified literature on contemporary readers, and the manner in which readers and writers interact to create meaning.
- 4. Examine how contemporary culture, including technological change, has affected interpretation of texts.
- 5. Situate works and writers within relevant social, cultural, political, and economic trends.
- 6. Use literary analysis to engage with and reflect on social, cultural, political, and economic relationships.
- 7. Write thoughtful literary analyses using appropriate terminology and conventions.

#### **Course Content:**

#### A. Texts

- 1. Instructor Selected Readings Based on Course Theme
- 2. Selections from One or More of the Following: TedTalks, Films, and Other Multimedia Based on Course Theme
- 3. Emphasis on One or More of the Following: Local Voices, Student Voices, Community Voices, and Found Texts

### B. Synthesis

- 1. Essays, and/or Short Writings, and/or Discussion Forums
- 2. Verbal and Visual Projects and/or Presentations
- 3. Artifacts Presented to and Including the Larger Community (Options May Include Service Learning, Exhibits, Poster Presentations, Talks, Interviews, Podcasts, Etc.)

## **Learning Assessments:**

Course competencies will be assessed using essays, in class and other short writing, discussion forums, projects, presentations and class discussions.
