Course Description:

An introduction to the principles of pharmacology, including drug terminology; drug origins, forms, and actions; routes of administration; as well as the use of generic name drugs, trade name drugs, and categories of drugs to treat various body systems.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Calculate Drug Dosage.
- 2. List several forms in which drugs are manufactured, their advantages, and disadvantages.
- 3. List several routes of drugs administration and describe their advantages and disadvantages.
- 4. List the steps of the drug cycle and explain how a drug is affected or changed.
- 5. Distinguish between local, systemic, therapeutic, allergies, and side effects of drugs.
- 6. Identify the trade names of common generic drugs used to treat each body system.
- 7. When given a common generic or trade name drug, identify the category it belongs to.
- 8. Describe the pharmacologic action of common drugs/drug categories/treat systems.
- 9. Pronounce and spell common generic and trade name drugs and their categories.
- 10. Define common drug abbreviations, including units of measurement.11. Demonstrate the proper use of drug reference materials.
- 12. Prepare and administer oral medication.
- 13. Prepare and administer an injection.
- 14. Reconstitute powdered drugs.
- 15. Prepare and administer subcutaneous medication.
- 16. Prepare and administer intramuscular medication.
- 17. Prepare and administer intradermal medication.
- 18. Administer Z-track injection.
