Course Description:

This course will focus on the principles and practices of teaching art to children from preschool through middle school.

Course Competencies:

Upon completion of the course, the student should be able to:

1. Explain the concept of art in terms of how it relates to the growth and development of children.
2. Identify and explain the developmental stages in learning art.
3. Encourage the development of creativity in children and explain methods used for developing creative potential.
4. Formulate and apply concepts related to goals, objectives, and outcomes for K-6 art education.
5. Use various methods and criteria for evaluation as they relate to K-6 art education.
6. Conduct Internet research concerning art education.
