# **Course Description:**

This course is a lab course designed to give students practical work experience to diagnose, repair, and understand the components of engine repair auto transmission/transaxles, and auto service management.

## **Course Competencies:**

## **Course Content:**

- 1. Identify, diagnose, replace or repair the components of engine repair.
- 2. Identify, diagnose, replace, or repair more complex components of the auto transmission/transaxle system.
