Course Description:

The course is continuation of Accounting I. The focus of the course will be on recording, classification, and analysis of economic transactions of the corporation. Students will analyze transactions, use journal and ledgers, prepare financial statements, and summarize results at the close of the fiscal period. Students will be introduced to decision-making and financial analysis.

Course Competencies:

The learning outcomes and competencies detailed in this syllabus meet or exceed the learning outcomes and competencies specified by the Kansas Core Outcomes Groups for this course as approved by the Kansas Board of Regents when taken in addition to HCC's BUS 103 Accounting I. Upon completion of the course, the student should be able to:

- 1. Identify and demonstrate the effects of transactions and economic events on the financial statements in corporations and other business entities.
- 2. Analyze and interpret the information presented in the financial statements.
- 3. Measure the value of assets and liabilities, including an introduction to fair value accounting.
- 4. Evaluate the quality of business decisions in an ethical context.
