- H. Working with Trendlines, Pivot Table Reports, PivotChart Reports, and Slicers.
- I. Formula Auditing, Data Validation, and Complex Problem Solving.
- J. Data Analysis with Power Tools and Creating Macros.
- K. User Interfaces, Visual Basic for Applications (VBA), and Collaboration Features in Excel.
