# **Course Description:**

This is the second of a two-course sequence in college English composition. The course will continue to emphasize improving the ability to organize and express thoughts in clear, effective writing. The course will use literature study as a basis for improving and extending research, critical analysis, and writing skills. The forms, elements, and techniques of literature will be examined in terms of how literature affects readers.

## **Course Competencies:**

The learning outcomes and competencies detailed in this syllabus meet or exceed the learning outcomes and competencies specified by the Kansas Core Outcomes Groups for this course as approved by the Kansas Board of Regents. Upon completion of the course, the student should be able to:

- 1. Compose a variety of texts addressing specific audiences.
- 2. Craft a sustained, well-supported argument
- 3. Apply research strategies including finding, evaluating, analyzing, and synthesizing sources.
- 4. Employ an appropriate documentation style.
- 5. Demonstrate the ability to read and think critically about texts.

#### **Course Content:**

- A. Fiction, Poetry, Drama, and Nonfiction
  - 1. Critical reading and understanding the text
  - 2. Responding and understanding themes
  - 3. Writing critically and applying critical vocabulary
- B. Research Methods
  - 1. Developing an assertive thesis
  - 2. Finding, evaluating, and summarizing primary and secondary sources in the form of an annotated bibliography
  - 3. Refining the argument
  - 4. Properly support a thesis with relevant evidence
  - 5. Documenting primary and secondary source material
  - 6. Revising

# **Learning Assessments:**

Course competencies will be assessed by essay assignments (including drafts and revisions), in-

class writing or exercises, written responses to reading assignments, level of active participation in class or group discussions, exams, quizzes, annotated bibliography, and a final written essay of at least four (4) pages that demonstrates the use and integration of both primary and secondary scholarly sources.
