# **Course Description:**

This course helps the student develop an understanding of coding and classification systems in order to assign valid diagnostic and/or procedure codes. It will include the validation of coded clinical information, and case mix/severity of illness data. The course will focus on basic diagnosis coding skill and guidelines associated with International Classification of Diseases, Clinical Modification (ICD-CM).

## **Course Competencies:**

Upon completion of the course, the student should be able to:

- 1. Differentiate the structure and use of the volumes in ICD.
- 2. Apply correct coding conventions in ICD.
- 3. Assign diagnosis codes according to current guidelines.
- 4. Sequence diagnosis codes according to current guidelines.
- 5. Evaluate the accuracy of diagnostic coding.
- 6. Assign procedure codes according to current guidelines.
- 7. Sequence procedure codes according to current guidelines.
- 8. Evaluate the accuracy of procedural coding.
- 9. Evaluate the accuracy of diagnostic/procedural groupings.
- 10. Consult reference materials to facilitate code assignment.
- 11. Apply the ICD Official Guidelines for Coding and Reporting.
- 12. Identify discrepancies between coded data and supporting documentation.
- 13. Follow the standards of ethical coding.
