# **Department:**

# **Course Description:**

This course helps the student develop an understanding of coding and classification systems in order to assign valid diagnostic and/or procedure codes. It will include the validation of coded clinical information, and case mix/severity of illness data. The course will focus on more advanced diagnosis coding skill and guidelines associated with International Classification of Diseases, Clinical Modification (ICD-CM).

## **Course Competencies:**

Upon completion of the course, the student should be able to:

- 1. Differentiate the structure and use of the volumes in ICD.
- 2. Apply correct coding conventions in ICD.
- 3. Assign diagnosis codes according to current guidelines.
- 4. Sequence diagnosis codes according to current guidelines.
- 5. Evaluate the accuracy of diagnostic coding.
- 6. Assign procedure codes according to current guidelines.
- 7. Sequence procedure codes according to current guidelines.
- 8. Evaluate the accuracy of procedural coding.
- 9. Evaluate the accuracy of diagnostic/procedural groupings.
- 10. Consult reference materials to facilitate code assignment.
- 11. Apply the ICD Official Guidelines for Coding and Reporting.
- 12. Identify discrepancies between coded data and supporting documentation.
- 13. Follow the standards of ethical coding.

### **Course Content:**

- A. Case mix analysis
- B. Severity of illness systems
- C. Coding compliance strategies, auditing, and reporting (such as CCI, plans)
- D. Coding quality monitors reporting
- E. Case studies using more complex code assignments with ICD-10-CM/PCS. Including PPS application examples for ICD coding (DRG, RUGS, HHRG, etc.)
- F. Introduction to Systematized Nomenclature of Medicine (SNOMED). Including a brief overview of its role in the healthcare delivery system as the basis for an electronic health record outlining its relationship to the administrative code set currently used for billing and statistical reporting
- G. Definition for crosswalks and maps used in the clinical coding process
- H. Authentic coding

## **Learning Assessments:**

Course competencies will be assessed by use of discussion questions, graded assignments, comprehensive assignments, research paper, quizzes, and exams.
