# **Course Description:**

This course covers terminology associated with domestic refrigeration, identification of types of domestic refrigeration, location of data plates and their purpose. Also covered will be sealed system components, what their function is and how they operate, as well as locating and solving programs in a domestic refrigeration system in a safe manner.

## **Course Competencies:**

Upon completion of the course, the student should be able to:

- 1. Explain principles of refrigeration.
- 2. Explain heat transfer theory.
- 3. Identify refrigerant and oil types, characteristics and uses.
- 4. Use gauge manifold set.
- 5. Leak-test systems.
- 6. Evacuate and measure vacuum level to 500 microns.
- 7. Recover refrigerants.
- 8. Charge system to manufacturer's specifications.
- 9. Describe the operations of refrigeration system accessories (e.g., receivers, accumulators, filter/dryers, sight glasses, valves, etc.).

## **Learning Assessments:**
