# **Course Description:**

Through classroom and /or lab/shop learning and assessment activities, students in this course will: perform safety inspections of equipment; make minor external repairs to equipment; set up components and accessories of a complete Gas Tungsten Arc Welding (GTAW) system; set up for GTAW operations; operate GTAW equipment; execute corrective actions to repair surface flaws on welds and base metals; make 5G welds on carbon steel pipe with carbon and stainless filler material; perform 6G qualification test on carbon steel pipe with carbon and stainless filler material.

# **Course Competencies:**

Upon completion of the course, the student should be able to:

- 1. Perform safety inspections of equipment.
- 2. Make minor external repairs to equipment.
- 3. Set up components and accessories of a complete gas tungsten arc welding system.
- 4. Set up for gas tungsten arc welding operations.
- 5. Operate gas tungsten arc welding equipment.
- 6. Execute corrective actions to repair surface flaws on welds and base metals.
- 7. Make 5G welds on carbon steel pipe with carbon and stainless filler material.
- 8. Perform 6G qualification test on carbon steel pipe with carbon and stainless filler material.
