Course Description:

This course provides an aural study of melodies, intervals, harmonies, rhythms, and meters.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Demonstrate improved listening and keyboard skills with regard to intervals, meters, and rhythm.
- 2. Demonstrate improved sight singing skills.
- 3. Accurately transcribe more complex melodies, harmonies, and rhythms.
- 4. Sight sing more complex melodies and harmonies, when given the starting key.
- 5. Play scales in major, natural minor, harmonic minor, and melodic minor.
- 6. Accurately transcribe more complex harmonic patterns, including supertonic, dominant 7th, and subtonic chords in keyboard and 4-part vocal style.

Course Content:

- A. Sight Singing
 - 1. Solfege
 - 2. Diatonic and chromatic intervals
 - 3. Melodies that do not begin on the tonic
- B. Rhythmic Dictation
 - 1. Simple and compound meters
 - 2. Division of beat
 - 3. Dotted patterns
 - 4. Rests
- C. Melodic Dictation
 - 1. Diatonic and chromatic intervals
 - 2. Seventh chords
 - 3. Stepwise and skipping melodies, utilizing non-chord tones
 - 4. Melodies that do not give the starting rhythmic value
- D. Keyboard Scales Review
 - 1. Major
 - 2. Minor (including natural, harmonic, and melodic variants)
- E. Harmonic Dictation
 - 1. Tonic triad review
 - 2. Dominant review
 - 3. Sub-dominant review

- 5. Supertonic chord
